**EVENT ATTENDEE WAIVER AND RELEASE OF LIABILITY FORM**  
**38<sup>th</sup> Annual Heritage Days**

The Starbuck Chamber of Commerce continues to monitor policy and procedures during the COVID-19 pandemic. The safety and well-being of our community, including guests and visitors, is our top priority. We are collaborating with federal, state, and local agencies to implement best practices aimed at managing the spread of the virus.

The Starbuck Chamber of Commerce has put in place preventative measures to reduce the spread of the COVID-19 virus; however, under no circumstances, is able to guarantee that you or a guest will not become infected with the virus while attending the event.

- I declare that should I be exposed to a person or animal with a positive and confirmed case of COVID-19 I will not attend the event.
